Dog Daycare & Boarding Waiver

Any references below to the word "I" also implies all others associated with me, including but not limited to my spouse, heirs, assignees, and family members. Any references to "Adventure Awaits" implies its agents, officers, owners, employees, subcontractors, customers, and prospective customers.

This section applies to all current and prospective customers, employees, subcontractors, or anyone else who enters the premises of Adventure Awaits Dog Daycare & Boarding.

I agree that if I get injured by a dog at Adventure Awaits Dog Daycare & Boarding, I will not hold Adventure Awaits Dog Daycare & Boarding liable for any injuries or damages that may occur.

- I have disclosed to Adventure Awaits Dog Daycare & Boarding all known risks, dangers, and medical conditions associated with my dog(s).
- I understand that I am solely liable for medical care expenses and damages that result from injuries caused by my dog, or that I will resolve the matter directly with the owner(s) of the other dog(s) based on applicable laws.
- I understand that Adventure Awaits Dog Daycare & Boarding may refuse service to my dog for any reason it deems necessary, including but not limited to, overly aggressive behavior, overly excessive barking, illness, and changes in habits and behaviors.
- I agree that there are inherent risks in sending my dog to any dog activity center, such as illness or injury, and I accept these risks because they are outweighed by the benefits. Adventure Awaits Dog Daycare & Boarding will not be liable for any illness or injury that may occur to my dog(s).
- I understand that I am financially responsible for the charges that my pet will incur during his/her stay at Adventure Awaits. I also understand that I am responsible for any damages (damages to bedding, drywall, etc.) that my dog(s) might inflict during his/her stay. All charges will be settled at the time I pick up my dog from his/her stay at Adventure Awaits Dog Daycare & Boarding.
- I authorize Adventure Awaits Dog Daycare & Boarding to take actions they deem as necessary to ensure the health, well-being, and safety of my dog(s), and to take

reasonable action to resolve any medical problems that may arise while my dog(s) is in their care.

- I agree to assume full financial responsibility for any and all expenses incurred as a result of their actions. I understand that Adventure Awaits Dog Daycare & Boarding staff is expected to make a reasonable attempt to contact me before incurring such expenses, that they may need to incur such expenses if they can't reach me, and that an emergency situation could arise where it would not be feasible for them to contact me before the expense is incurred, including but not limited to, first aid, CPR, and/or emergency veterinary care.
- I understand that, as is the norm in the pet care industry, under no circumstances will Adventure Awaits Dog Daycare & Boarding be liable for damages beyond the replacement value of my dog(s).
- I waive all claims or actions against Adventure Awaits Dog Daycare & Boarding, relating to the care, control, health, and/or safety of my dog(s) arising while my dog(s) is in their care.
- If my pet is here more than five days past the scheduled pick up date, Adventure Awaits Dog Daycare & Boarding will consider the pet abandoned and may take the pet to the local shelter. Additionally, I will be billed for all applicable fees while my pet was in care.
- I understand that although my dog is vaccinated they can still get kennel cough or other respiratory issues. All dogs that are showing signs of kennel cough need to be treated by their veterinarian and treated with antibiotics. Kennel cough can be spread at the groomer, at the dog park, at the vet, even just by touching noses with another dog.
- I understand that Adventure Awaits Dog Daycare & Boarding is not responsible for recalled food or treats.
- I understand that Adventure Awaits Dog Daycare & Boarding is not responsible for food allergies.
- For the safety of my dog, I understand that only the people listed as my emergency contacts can pick up my dog.
- Adventure Awaits may take a dog outside of the premises for a short walk or brief change in environment at the discretion of Adventure Awaits management and subject to weather and other conditions. The dog will be leashed and under the supervision of Adventure Awaits staff during all times the dog is outside of the premises. There is no additional charge to Owner for this service. **This is always discussed beforehand with clients - usually for dogs staying longer than 4 weeks.**
- If my dog is staying overnight, owners of Adventure Awaits have my permission to take my dog home with them. **This is always discussed beforehand with clients - usually for dogs staying longer than 4 weeks.**

- While we are experts in our field and love offering advice and tips, always consult with your vet.
- Dogs are not allowed in the facility while in heat. A heat cycle for a dog can last 1-2 weeks and common signs include a swollen vulva, behavioral changes, blood discharge, excessive licking at vulva or more frequent urination.
- Once a puppy turns 7 months old, she/he is required to be spayed/neutered before returning to play as they will then be a part of our regular play groups.
- I give Adventure Awaits permission to take photos and videos of my dog(s) to use on social media platforms and for marketing
- Senior dogs - Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to transport Owner's dog to Owner's vet where he/she will be held until Owner can be reached by the Vet for further instructions.

I certify that:

- I am the legal owner of the dog(s) I am sending to Adventure Awaits Dog Daycare & Boarding
- That, to my knowledge, my dog(s) has not been exposed to kennel cough, distemper, rabies or parvovirus within the past thirty days.
- My dog(s) has been vaccinated and had their fecal plus Giardia test as indicated on the Adventure Awaits Enrollment Form

I agree to indemnify and hold harmless Adventure Awaits Dog Daycare & Boarding from any and all injuries, damages, and/or losses incurred by Adventure Awaits Dog Daycare & Boarding and/or its employees resulting from my dog's stay at Adventure Awaits Dog Daycare & Boarding, without limitation, and to reimburse Adventure Awaits Dog Daycare & Boarding for any and all associated legal fees and collection costs.
